

# SPORTS REGULATIONS

36th ARMOR FESTIVAL Challenge CREDIT AGRICOLE (Category U17) Players born between 01/01/2001 and 31/12/2002

### 1 - Tournament organizer

#### The association **UNION SPORTIVE PLOUGONVELIN (U.S.P)**

Association law 1901, declared to the sub-prefecture of Brest under the number 1487 and the No. W291002236 corresponds to the receipt of declaration of modification of the association, N ° siret 7775928300019, Code of activity 926 C, N ° youth and Sport 001342 whose registered office is at Mairie de PLOUGONVELIN, Rue des Martyrs-29217 PLOUGONVELIN (France) represented by Mr Yvon Lainé, co-chairman, duly authorized to the effect of the present

### 2 - Dates and location of the tournament

This tournament is organized every year during the weekend of Pentecost in the territory of the commune of PLOUGONVELIN. For 2018, the tournament will take place on May 19, 20 and 21, 2018..

#### **3-** Participating Teams

The list of participating teams will be announced after the draw, ie at the beginning of April 2018.

Only teams affiliated with a recognized national association are allowed to participate in the tournament. A player may only play for one team during the tournament.

The club's delegation will consist of a maximum of 20 participants. (16 players and 4 managers maximum).

#### 4 - Rules of the Game

All matches shall be played in accordance with the laws of the game as issued by the International Football Association Board (edition in force on the day of the match), unless otherwise mentioned in these rules.

The number of players per team is limited to 16. The dimensions of the pitch are: length 100 meters; Width 65 meters.

### **5 - Tournament Commission**

The organizer will set up a tournament commission which will be in charge of the tournament's sporting activities and will have the power to decide disputes, rule on complaints and / or appeals and generally to rule on any question or difficulty whose competence Is not vested in another authority under this Regulation. This commission will consist of the FESTIVAL D'ARMOR steering committee and one or more members of the official delegations (arbitration, district, league, French Football Federation).

If necessary, the tournament commission will report to the corresponding national association and / or to the International Football Organizations (FIFA / UEFA)

#### 6 - Referees

All matches will be led by referees affiliated to the Fédération Française de Football (FFF).

The referee will be required to communicate the final result of each meeting to the tournament commission.

#### 7 - Age category

All players authorized to play will belong to the following age category:

For the U.17: birth years 2001 and 2002

#### 8 - Duration of matches

The matches will last  $2 \times 20$  mn (qualifying matches until the final match) The break at half-time will last 5 minutes. In the event of a tie, there will be no extra time.

#### 9 - List of Players and Substitute Players

Each team may enter a maximum of 16 players during the tournament. The list of the 16 players will be affixed on a sheet of game on Saturday before noon at the stadium. This match sheet can not be modified or completed during the competition.

A single player will keep the same number throughout the competition. Among the 16 players, it is possible to involve 4 players not licensed in the club but they must be insured and belong to the age category mentioned in article 7.

Three players may be substituted at any time in a match by a 12th, 13th and 14th player selected from 5 substitutes. A substitute player during a match will not be able to come back into play during the match.

In addition, the goalkeeper may be replaced at any time by the substitute goalkeeper once per game. This replacement does not occur in the case mentioned above. An excluded player can not be replaced and can not participate in the following match.

#### 10 - Tournament System

The tournament will take place according to the following game system:

- 4 groups of 4 teams.
- The top 2 of each group will qualify for the 1/4 finals
- The other teams will play ranking matches.

#### 11 - Match Programs

The Tournament Commission reserves the right to modify some schedules in order to ensure the smooth running of the tournament.

#### 12 - Points system

The following points system will be applied during the tournament:

- > 3 points per game won
- > 1 point per draw
- > 0 points per lost match

> 1 °) The goal average (difference of goals scored and cashed),

- first of all,
- General then.

> 2°) The best attack

> 3 °) The average age of the sixteen participating players; The youngest team will be qualified.

B) Quarterfinals, semi-finals and final and ranking matches

In the event of a tie at the end of the 1/4 and final, 1/2 finals, final and ranking matches, the teams will decide by drawing on the same goal designated by the referee, a first series of 5 shots Goal made by 5 different players, chosen from the 11 players present on the field at the final whistle. In the event of a new tie at the end of that series, the event is continued in the same order until one team has scored one goal more than the other after the same number of attempts.

## 13 - Player Equipment

Each team must be equipped with:

- > 3 sets of different colors
- > 1 pharmacy box
- > 10 pennants (for exchanges before matches)

The team named second in the program will have to change clothes if the referee considers that it is not possible to clearly distinguish the colors of the two teams.

### 14 - Disciplinary sector

Red card - expulsion: a player who has received a red card will be suspended for the next match.

Yellow card - official warning: A player who has received two yellow cards during the tournament will be suspended for the next game.

If a player behaves unsportsmanlike, the case will be reported by the tournament commission to his national association, which will decide on appropriate measures to be taken with regard to the player. If a delegation member behaves in a seriously incorrect manner during the tournament, the tournament commission will communicate it in writing to the relevant national and international football associations.

# 15 - Certificate of identity

Each participant must have his / her identity card or an official document with a photo. The control of the ages may, on the basis of the match sheet, be made by the tournament commission before the first match of each team. At the request of the Organizing Committee, official licenses or documents must be deposited with the match sheet on Saturday morning at the stadium at the said Commission. After checking the game sheet, the official documents will be immediately returned to the team leaders.

## 16 - Accidents

IMPORTANT: in the event of an accident requiring medical intervention, the authorization of the parents is compulsory. All participants and accompanying persons must be insured by their club for all risks of accidents.

## 17 - Complaints and appeals

Complaints and appeals must be addressed to the Tournament Commission, which will take a final and binding decision. The Commission will not accept any claim concerning decisions of the referee in the field.

## 18 - Tournament Approval

The organizer is responsible for obtaining all necessary national and / or international approvals for the tournament at least two months before the start of the tournament.

#### 19- Match Agents

Only UEFA and / or FIFA licensed match agents, a club or an association may arrange the participation of clubs / associations in tournaments.

#### 20 - Acceptance of the Regulation

Participation in the FESTIVAL D'ARMOR implies the acceptance of the present rules and a signed copy of the person responsible for the delegation will be handed to the organizing committee on Saturday, May 19 at 14h00.
